1 Preface

1.1 Report to Annual General Meeting

This Annual Report of the Berwick Bowling Club (Inc) was compiled in May 2023 by the current Board of Management. It will be submitted for approval by the members at the Annual General Meeting (AGM) on Wednesday 17th May 2023 at 7pm.

1.2 Board Procedures – Caretaker mode

The Term of office for the 2022 – 23 Board expired on 31st March 2023, and it remains in ‘caretaker mode’ until a new Board is elected and confirmed at the AGM.

The current Board will continue to make decisions as appropriate until the AGM and the results of any elections are known. The Board will ensure that those members who lodge their nominations for any new Board position will be advised of any deliberations where actions taken will flow onto the new season and the new Board. The current Board assumes responsibility to make any such decisions.

The “handover” to a newly elected Board will be relatively seamless.

2 Introduction

2.1 Background

The Berwick Bowling Club (Inc.) Board of Management (the Board) is pleased to present this Report. It describes the Club's performance over the past financial year (1st April 2022 to 31st March 2023).

This Report is designed to place on the public record our Club's achievements over the past year and to meet our obligations under Section 63 and Part 7 of Associations and Incorporation Reform Act 2012 (Vic) **(AIR)**.

The Board has obtained external assurance of the accuracy and integrity of the financial statements in this report and the supporting information from BJT Business Advisors.

Our website at www.berwickbowlingclub.com.au provides more information about the Club's activities and our Pennant results.

The Club is affiliated with Bowls Victoria. Bowls Victoria is the governing body for the sport of bowls in the State of Victoria.

This Annual Report is written in the structural framework of our Constitution and **AIR**.

Our priorities are to facilitate:

- Enjoyment and satisfaction in playing the game of bowls.
- Intra club social games and championships, and inter club pennant games as organised by Bowls Victoria; and
- Social inclusion and opportunities for members and visitors to interact with each other.

2.3 Overview

Berwick Bowling Club welcomes new members of all ages and experience. We offer free coaching to help players get started and coaching clinics are regularly held to improve skills of more experienced bowlers.

There is a large function room, fully equipped kitchen with bar for use by members, and it is available for hire. In a garden setting with ample car parking, our facilities are ideal for weddings, dinners, birthday parties, business seminars and similar events.

The Club provides a venue and facility that is an integral part of the Berwick community, where we encourage visitors and our membership to participate at all levels in the sport of lawn bowls.

2.5 Club Governance



2.7 Berwick Club - Tier Two Association

Consumer Affairs Victoria defines the operations of the Berwick Bowling Club Inc. as a Tier Two association.

For a Tier Two Association as defined, the financial statements must be reviewed by an independent accountant, in accordance with Auditing Standards on Review Engagements.

An independent accountant must be:

1. a member of, and hold a current practicing certificate issued by either CPA Australia, the Institute of Chartered Accountants Australia or, Institute of Public Accountants, or
2. any other suitably qualified person approved by the Registrar of Incorporated Associations for this purpose, such as a member of the Association of Taxation and Management Accountants holding a current practicing certificate.

The Club's financial records have been reviewed by the Club's accountants BJT Business Advisors. The attached report – refer Appendix B, was prepared by the accountant, and presents a true and fair view of the Club's financial performance and position during and at the end of the year.

The financial statements contain:

1. income and expenditure (Income Statement) for the financial year.
2. assets and liabilities (Balance Sheet) at the end of the financial year.
3. other documents required by accounting standards, such as a cash flow statement;
and
4. notes to the account, which must include:
 - a. information required by the accounting standard.
 - b. information necessary to give a true and fair view; and
 - c. information required by the provisions of the Act and its regulations.

For further details regarding our financial performance please refer to the Treasurer's Report and supporting information.

3 Projects Report

3.1 Progress of the Roadmap

The Berwick Bowling Club's Strategic Plan 'A Roadmap to 2030' was adopted in March 2018. The roadmap sets out aspirational goals for capital improvements, financial management and player skills development. Three Stages of Development were finally presented to a General Meeting of Members in 2019 and approved.

Stage One: Conversion of Green 3 from grass to synthetic – now completed.

Stage Roof Two: Roof over Green 3 – now completed.

Stage Three: Viewing Area and Alterations to Clubrooms – deferred for review.

Stage Three has been reconsidered by the Board and it is recommended that it and the roadmap should be reviewed, and that it be listed as an Item for consideration by the new Board in 2023-24.

3.2 Funding

Over the past 3 years there has been a major investment in infrastructure associated with the roof over Green 3.

4 Message from the Chairman of the Board

Hi Everyone,

As we complete another season, it is good to reflect on what has taken place over the last year. From a Board perspective it has probably been one of the busiest years for quite some time, I am sure the many members who help each week feel the same way. At last year's AGM, there was a call from the floor to introduce a General Manager position, to help bring in more opportunities and utilise our facilities more. On a positive note, the roof was completed to a satisfactory stage that it was being used from the second half of Pennant. I think it is fair to say that this was a very positive outcome which was well received by members and visitors alike and well worth the trials and tribulations we went through during the installation. We are still putting the final touches to the surrounds with shelters, synthetic grass for surrounds, as well as the upgrading of lights to green 1 & 2, which is being funded by council, due to the wiring issues caused by the roof construction.



Once these items are finished, they will further enhance our facilities and bowling experience at Berwick. I would like to take this opportunity to thank the Board for being able to fund these additional items through great financial planning, a lot of hard work and we still have money in the bank. This is a fabulous outcome and something you should all be very proud in achieving.

From a bowling perspective, it may not seem that we followed on from the previous year and maybe not as successful as a result. The super sixes flew the flag for Berwick this year

and achieved a tremendous result. The camaraderie among that group during finals was there for all to see and that helped them during their finals campaign. Other sides made finals too but didn't achieve what they thought they would.

Success must be earned and when the opportunity presents itself, you must be ready, as it doesn't come along as often as we would all like it too. Who knows what the upcoming season has in store for us but you only get out what you put in. First and foremost, it is about enjoyment while working as a team, if that isn't happening the results will be more negative than positive. I am sure there will be discussion around coaching, drills, organised pennant practice and who knows what else before the new season starts. Whatever that looks like, embrace it, and get on board.

In closing I would like to thank the Board members for your support and hard work throughout the year. You should all be very proud of your efforts.

5.2 2021 – 2023 Trading Results

Trading results over the past 3 years are summarised in the following table.

Annual turnover has increased but our expenditure has also similarly increased leaving us with a bare minimum profit for the year as shown in the following table.



These trading figures show a significant reduction in net profit in 2023 compared with 2021/22 years. In 2021 and 2022 we received several grants from Government in those years relating to Covid 19 distorting the effects on our income affecting the club's profit in each of those years. Turnover in the past year improved significantly, however expenses also increased, and the lack of any external grant funding we received has affected the bottom line, so that we accumulated a negligible profit in 2023.

The extra efforts by the volunteers to maximise income through the bar, barefoot bowls, functions, and hall hire is to be applauded and has provided adequate income to cover the additional expenses.

6 BOWLS SECTION

2022/2023 has been a very arduous task and for many reasons. Our season, some will argue I'm sure, was quite successful without getting the ultimate results. Finals through pennant didn't go as planned but that's bowls, that's life! Sometimes the opposition is just better than you on the day and unlike the home and away season, finals is a one-off day and to the better team on that day goes the spoils.

Our Midweek Pennant numbers were down on previous years which really did compromise the depth of our sides. Although we had one side make finals, others had their chances but just fell short. Numbers is the key for midweek pennant next season and without more playing the results are likely to be similar without more depth.

The Weekend Pennant sides overall performed reasonably similar in numbers to 2021/22.

Some will say that's hard to believe. Here are the numbers:

In addition to the above numbers, we had our Division 1 side go in to an open draw and as such a much tougher draw, our 3s, 6s and 7s all played in a higher Division than they did in 2021/22.

So, in saying this these numbers say "overall" that our year was very similar to last albeit, without getting the same results. Four of our eight teams played finals (2s, 4s, 6s and 7s) and two just marginally missed (1s and 5s).



One side, our 6s played brilliantly to win their section and were rewarded with a Divisional grand final playoff where they fell short.

Division 6 Grand Finalists

Shot difference to me is the only standout number and with those shots against where we performed well below 2021/22!! This comes down to many different and varying reasons but I can pretty much guarantee a lot of it, comes down to shot selection by 3rds and skips during games. To have only two less wins and five more losses than the year previous, this number is alarming and an area that requires more education and mentoring going forward.

The club is now in a period of transition where it needs to decide if it wants to push ahead and improve, attract more talent and ultimately strive for the pinnacle of Pennant bowling in reaching Premier League OR is it just happy being an average Division 1 club. Without structure, discipline and a more structured approach around pennant and its requirements to improve, the rise to the pinnacle won't happen and we will continue to lose talented bowlers. This is a decision we as a club have to make going forward.

During the 2022/23 season we were lucky enough to again be the host for the annual Integrated Pairs tournament. Jeff Janetzki was the manager for the day and the event went off without a hitch as we had 3 full greens, and all participants and spectators loved the "new" Berwick Bowling Club.

The ability of the disabled and handicapped bowlers is amazing, and we are in awe of their capabilities and attitude towards bowls. Bowls Victoria look no further than Berwick BC to host the event and it is one that always provides great exposure for our club. It is great to give back to the communities in such a very positive way.

I'd like to take the opportunity again to thank all that helped with our Bowls events throughout the season and encourage more of our members to offer help in any way they can, be it coaching, umpiring, convening and all other areas including administration of bowls. We need the help and can't continue to provide the level of bowls at the club that we do without continued, ongoing and new help from members.

The following reports are from our relevant bowls committee Chairs for this season. I would like to take this opportunity to thank Geoff & Cheryl Dawson, Pat Thompson, Dennis Fry, David & Sue Conrad, Leon Muir, Jeff Janetzki, and Peter Hodgson for all of your efforts and support throughout the year helping out with bowls. I apologise if I've missed anyone.

6.1 TOURNAMENTS – John Rich

This year was one of our best seasons for holding tournaments. A big thank you goes out to Jean Fothergill, Jeff Parker and Cheryl Dawson and their band of helpers to get our tournaments off the ground and provide events for not only our members but those of the bowls community in Metro and regional areas that came and experienced Berwick BC at its' best.

CASEY FOURS – We had been speaking about bringing this event back in a different format etc. for some time. After having to cancel the event in April 22 it was rescheduled to the 6th & 7th January.

(Friday & Saturday). A full field of 42 teams was entered (168 bowlers). Initially, we had requested \$5000 from the Board to go towards the event to help with prizemoney and costs for the event.

During the year we had secured over \$9000 in sponsorship which enabled us to forego the need of the BBC contribution. Breakfast was offered over the two days as well as a hot lunch served on both days. The help from all involved was a pleasure to see. It takes many hands to make the events successful and to everyone that helped out with the Casey Fours we thank you immensely for your contributions. All in all, the event raised \$8000 in profit. We hope that in 2024 we can raise the prizemoney further and work is already underway in the background on the organization of the event.

6.2 WEEKEND PENNANT

This season was looking very promising after the year we had before. Again, we had Members committing to play bowls this season, so again, we entered the 8th side, so everyone would get a chance to play pennant and we did have some great results with Sides making finals.

It is no easy task selecting 120 bowlers each Saturday to play, as well as trying to make sure we get the right mix.

A big thankyou to the selection committee of John Rich, Roy Down & Doug Fisher. It was a great team effort. It was a tough season, but we worked well together despite the negativity.

Thank you to all our Umpires, Measurers, Side Captains, Team Managers, duty rinks & bowlers who came to practice and completed vote cards correctly (we do look at them) and contributed to this season.

Special thanks to Greg Marsh for running Saturday Bankers, we need this as we draw on bowlers to fill pennant sides due to unavailability and our "Sausage Man" Dennis Fry. Greatly appreciated.

Again, thanks to all the Volunteers around the club.

Side 1 – Division 1, Section 4 (18 rounds) Open Draw

After winning the Section Flag last season Berwick 1 started off the season "full steam ahead" with 4 wins in a row against Pakenham, St Kilda, Whittlesea & Brunswick placing them on top of the ladder.

They then came against the likes of Heathmont, Flemington/Kensington & Bacchus Marsh to slow them down. Overall, a good season in the Open Draw considering the Sides they were playing and the travel they did. Landing 5th on the ladder with 9/18 wins. 22 bowlers played in this side.

(Whittlesea 1 defeated Heathmont 1 in Grand Final (85/75))

Side 2 – Division 2, Section 7 (14 rounds)

Berwick 2, after missing out on the Section flag by 1 shot to Dandy Club, started this season off with 6 wins out of the 7 to get top spot on the ladder, where they stayed pretty much all-season ending 1st place on 180 points to closest rival Clayton 3, 2nd on 134 points. (With 10 wins, 3 losses & 1 draw, winning all their homes games. 25 bowlers played inside 2).

Home ground advantage in finals, saw the 2's playing at Home. Unfortunately, defeated by Clayton 3 on day (71/85). 2nd chance against Mordialloc at Cheltenham again in a close game with the 2's fighting back, only to be defeated by 1 shot 71/72. (Clayton 3 defeated Mordialloc 1 in Grand Final).

Side 3 – Division 2, Section 8 (14 rounds)

Berwick 3 has a massive challenge this season playing against the top & second sides from opposition clubs after winning the section last season & been promoted from Div 3 to Div 2.

After several losses it was decided to give some bowlers a chance to play Div 2 bowls with some of our experienced bowlers to mentor.

A special thanks to Ken Graeber, Bruce Anderson & Roy Down for guiding & giving bowlers an opportunity to play higher level bowls. Thanks to all who played inside 3 and turned up week after week to give it your best shot. It's very hard losing every week, but what doesn't break you, makes you stronger, and hopefully you all learned a lot from the season. Thanks to all 38 bowlers who played in Side 3. (11 losses, 3 wins. 8th place)

Side 4 – Division 4, Section 8 (14 rounds)

Berwick 4 had a great season also starting off with 3 wins in a row to make it 11/14 wins & 3 losses after been relegated from Division 3 last season.

2nd Place on ladder, they made their way to Preliminary final to go down by 1 shot to Mulgrave CC3 79/80. Side 4 for last few years have had tough draws and have also done the club proud. (37 bowlers played in side 4)

Side 5 – Division 5, Section 8 (14 rounds)

Berwick 5 also had a great season compared to previous season after been relegated from Div 4, with 8/14 wins to land 5th on ladder, just missing out on 4th place by 1 point. (35 bowlers played in side 5)

Side 6 – Division 2, Section 8 (14 rounds)

Our Super 6's, what can I say, Section Runners up last season, started with 9 straight wins, a draw, another win, then 3 losses, seen the 6's land 3rd on ladder. Defeating Cranbourne RSL 1 at home 93/55 in semi-final, then defeating Dandy Club 5 83/56 at Burden Park in preliminary Final 83/56, then to defeating Cranbourne 4 at Noble Park 92/80 to win the Grand Final and become Div 7, Section 8 Winners.

Then on to divisional Finals, playing Wallan 2 at Ivanhoe defeating them 65/59 in a very close game.

Next to Mulgrave Country Club to play Moorabbin 4 in the Preliminary Final defeating them 96/62 to move onto the Grand Final.

Divisional grand Final played at Glen Waverley against Monbulk Cockatoo 1.

The 6's were defeated in this game 73/84 by Monbulk Cockatoo 1.

Side 7 – Division 8, Section 7 – 12 a side (14 rounds)

1st place on ladder with 11/14 wins & 3 losses. (31 bowlers played).

Wow, another great start with 8 wins out of first 9 games, the 7s were well on their way, winning all home games.

Semi-final was played at home and saw the 7's defeated by Churchill Waverley Golf 2 69/58.

Second chance had in Preliminary final at Burden Park against Mulgrave CC 6.

Mulgrave defeating Berwick 70/69. Again, with this 1 shot losing margin. 😞

Thanks to Carol Klooster for her amazing effort in gaining many raffle prizes for the 2023 Corporate Challenge. Most weeks we had around 15 prizes (the longest draw in history!). We had weekly prizes from sponsors valued on average at \$1,250 and great support from both past and new sponsors. With Pat & Avril Steere again in charge of ticket sales, we picked up approx. \$4,000 from this fundraising activity. We also had a couple of auctions. (Wickonian's Membership; Daikin air purifier) that contributed a further \$1,000.

With Ray White coming on a Major Partner for the Corporate Challenge, and our weekly sponsors PMM, Pedders', Stockland/Halcyon Berwick, and A Space we obtained \$3,200 for sponsorship of this important event.

David Bond remained our Member Draw sponsor for the pennant season, and thanks to Helen and Peter Adair for arranging most of the weekly raffle prizes including meat trays and other items. Thanks to Karl Lapinskas for hosting the raffle drawn at Happy Hour along with all the normal ticket sellers including both Helen's, Julie, and others.

We have worked hard for the past 6 months in securing Stockland/Halcyon Berwick as another major partner to our club with a sponsorship package worth \$10K. We are very excited to have a more formal partnership with Chantelle Pay and her team at Stockland and will launch this very soon.

On top of the sponsorship revenue increase this season, we managed to also obtain some contra deals to the value of \$1,240 from Atura Hotels/Brownstone Micro Brewery.

These vouchers were used for raffles including Happy Hour, tournaments, and Corporate Challenge. The \$8K sponsorship (\$3K Berwick Mazda raffle) for the Casey Fours was paid in the previous 21/22 financial year although the event itself was delayed until 5th January 2023. This helped inflate the previous year results.

Notes to the Financial Statements

Berwick Bowling Club Inc For the year ended 31 March 2023

1. Statement of compliance

The committee has determined that the incorporated association is not a reporting entity because there are no users dependent on general purpose financial statements. The financial report is a special purpose financial report which has been prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Reform Act 2012*

These financial statements have been prepared in accordance with following Australian Accounting Standards:

AASB 101 Presentation of Financial Statements

AASB 107 Statement of Cash Flows

AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors

AASB 1031 Materiality

AASB 1048 Interpretation of Standards

AASB 1054 Australian Additional Disclosures

Basis of measurement

The financial statements have been prepared on an accrual basis and are based on historical cost and do not take into account changing money values except where specifically stated.

Statement of significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

Property, Plant and Equipment (PPE)

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Property

Freehold land and buildings are shown at their fair value, being the amount for which an asset could be exchanged between knowledgeable willing parties in an arm's length transaction. Any accumulated depreciation at the date of revaluation is eliminated against the gross carrying amount of the asset and the net amount is restated to the revalued amount of the asset.

Plant and equipment

Plant and equipment are measured on the cost basis less depreciation and impairments losses. The carrying amount of plant and equipment is reviewed annually by the committee members to ensure that it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

Depreciation

The depreciable amount of all fixed assets, excluding freehold land is depreciated on a straight-line basis over the asset's useful life to the association commencing from the time the asset is held ready to use.

The depreciation rates used for each class of depreciable asset are:

Buildings 2%

Plant and equipment Between 7% and 25%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are recognised immediately in profit and loss. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

Income tax

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits, held at call with banks, other short-term highly liquid investments with original maturities cash within three months

Revenue

Revenue is measured at the fair value of the consideration received or receivable. Donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

Inventory

Inventory held for sale are measured at the lower of cost and net realisable value.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in active market and are stated at amortised cost using the effective interest rate method.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.
